TRIBAL RESOLUTION # 102623-102 TO APPOINT MELISSA PAMP AS A DELEGATE FOR THE NATIONAL CONGRESS OF AMERICAN INDIANS

- WHEREAS, the Waganakising Odawak Nation, known as the Little Traverse Bay Bands of Odawa Indians, and its citizens are vested with inherent sovereignty and right to self-governance; and
- WHEREAS, the Little Traverse Bay Bands of Odawa Indians (LTBB) is a federally recognized Indian Tribe under Public Law 103-324, and is a party to numerous Treaties with the United States, the most recent of which is the Treaty of Washington of March 28, 1836 (7 Stat. 491) and the Treaty of Detroit of 1855 (11 Stat. 621); and
- WHEREAS, the Little Traverse Bay Bands of Odawa Indians Tribal Council is the elected governing body of the Tribe;
- **WHEREAS**, the Little Traverse Bay Bands of Odawa Indians desires to continue representing the Tribe at the NCAI meetings;
- **WHEREAS,** the Tribal Chairperson has nominated Tribal Councilor Melissa Pamp as a delegate;
- **WHEREAS,** the NCAI requires the delegates to be appointed by their Tribal Council by resolution;

THEREFORE, BE IT RESOLVED that Tribal Council appoints Melissa Pamp as a delegate to represent the Tribe with the National Congress of American Indians until a successor is appointed.
