TRIBAL RESOLUTION# 042524-03

Supplemental Funding in the Amount of \$65,465.73 to come from Traditional Tribal Burial Board for FY 2024 Cemetery Development and Maintenance Fund

WHEREAS, the Waganakising Odawa Nation, known as the Little Traverse Bay Bands of Odawa Indians, and its citizens are vested with inherent sovereignty and right to self-governance; and

WHEREAS, the Little Traverse Bay Bands of Odawa Indians (LTBB) is a federally recognized Indian Tribe under Public Law 103-324, and is a party to numerous Treaties with the United States, the most recent of which is the Treaty of Washington of March 28, 1836 (7 Stat. 491) and the Treaty of Detroit of 1855 (11 Stat. 621); and

WHEREAS, the Little Traverse Bay Bands of Odawa Indians is governed by a Tribal Constitution adopted by the citizens of the Tribe on February 1, 2005; and

WHEREAS, Tribal Council authorizes and appropriates budgets through Tribal Resolutions; and

WHEREAS, Tribal Council has designated the Traditional Burial Commission to operate under the Executive Branch;

THEREFORE, BE IT RESOLVED, The Tribal Council authorizes and approves Supplemental Funding in the amount of \$65,465.73 for FY 2024 to resolve any outstanding liabilities related to the previous Burial Board and for the Cemetery Development and Maintenance Fund to come from the Fund received by the Traditional Tribal Burial Board on January 2, 2024.

FINALLY, BE IT RESOLVED that in accordance with the Constitution, the Executive Branch shall administer such funds as appropriated by Tribal Council.
