Supplemental Funding in the amount of \$124,283.40 for the purpose of constructing the Archie Kiogima Jr.-ba Migizi Aviary and Rehabilitation Center

WHEREAS, the Waganakising Odawak Nation, known as the Little Traverse Bay Bands of Odawa Indians, and its citizens are vested with inherent sovereignty and right to self-governance; and

WHEREAS, the Little Traverse Bay Bands of Odawa Indians (LTBB) is a federally recognized Indian Tribe under Public Law 103-324, and is a party to numerous Treaties with the United States, the most recent of which is the Treaty of Washington of March 28, 1836 (7 Stat. 491) and the Treaty of Detroit of 1855 (11 Stat. 621); and

WHEREAS, the Little Traverse Bay Bands of Odawa Indians is governed by a Tribal Constitution adopted by the citizens of the Tribe on February 1, 2005; and

WHEREAS, Tribal Council authorizes and appropriates budgets through Tribal Resolutions; and

WHEREAS, the Natural Resources Department continues its effort to fundraise for the Archie Kiogima Jr.-ba Migizi Aviary and Rehabilitation Center;

THEREFORE, BE IT RESOLVED, The Tribal Council authorizes and approves Supplemental Funding in the amount of \$\$124,283.40 for the purpose of constructing the Archie Kiogima Jr.-ba Migizi Aviary and Rehabilitation Center to come from the General Fund – Fund Balance.

FURTHER BE IT RESOLVED, The Tribal Council authorizes and approves the amount of unspent funds to carry forward into the 2025 budget for the purpose of constructing the Archie Kiogima Jr.-ba Migizi Aviary and Rehabilitation Center

FINALLY, BE IT RESOLVED that in accordance with the Constitution, the Executive Branch shall administer such funds as appropriated by Tribal Council.
