Revenue Fund Balance for Electronic Health Record (EHR) Transition and related
implementation costs

- WHEREAS, the Waganakising Odawak Nation, known as the Little Traverse Bay Bands of Odawa Indians, and its citizens are vested with inherent sovereignty and right to self-governance; and
- WHEREAS, the Little Traverse Bay Bands of Odawa Indians (LTBB) is a federally recognized Indian Tribe under Public Law 103-324, and is a party to numerous Treaties with the United States, the most recent of which is the Treaty of Washington of March 28, 1836 (7 Stat. 491) and the Treaty of Detroit of 1855 (11 Stat. 621); and
- WHEREAS, the Little Traverse Bay Bands of Odawa Indians is governed by a Tribal Constitution adopted by the citizens of the Tribe on February 1, 2005; and
- WHEREAS, Tribal Council authorizes and appropriates budgets through Tribal Resolutions; and
- WHEREAS, the Health Department conducted a Request for Proposals for an EHR system in 2024; funds are needs to purchase software, required hardware cover conversion costs and training and staffing to in order to provide improved health services to our Tribal Community;

THEREFORE, BE IT RESOLVED, The Tribal Council authorizes and approves Supplemental Funding in the amount of 1,566,320.69 to come from the Health Third Party Billing Revenue - Fund Balance for the EHR system and additional related costs. Funds will remain available until December 31, 2025 to ensure project completion.

FINALLY, BE IT RESOLVED that in accordance with the Constitution, the Executive Branch shall administer such funds as appropriated by Tribal Council.
