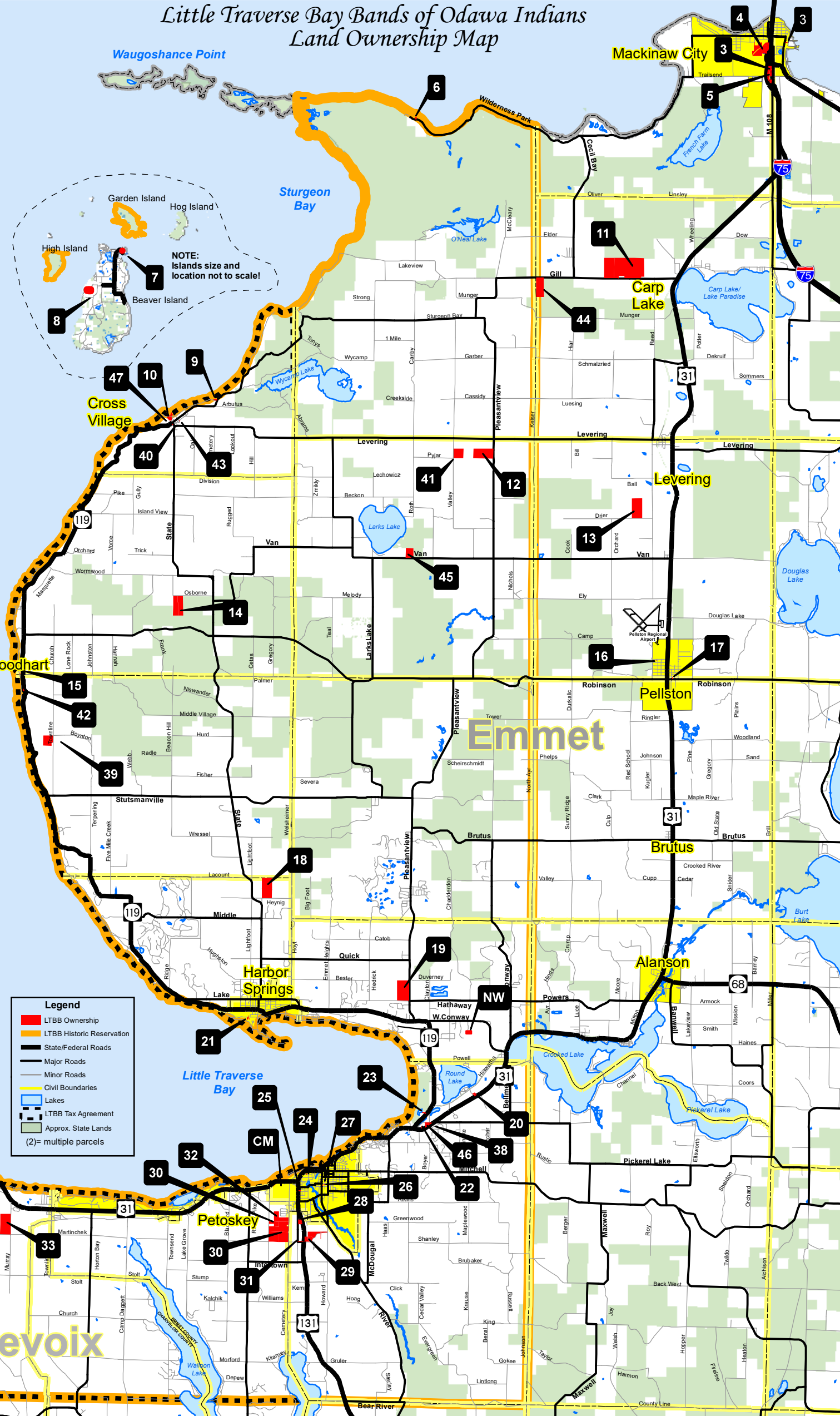


Little Traverse Bay Bands of Odawa Indians Land Ownership Map

Market with farm grown produce, GL fish products. Also Lake Huron docking access.
- 4** **Pond Street Parcels, 65.22A (3)**
Large tract of wetlands designated as wild area that is open to Tribal hunting.
- 5** **Adj. King's Inn Parcels, 7.7A (5)**
Group of parcels surrounding former site of King's Inn Motel. Site for future economic development.
- 5** **OEAH Parcel, 1020 Nicolet, 1.7A**
Former King's Inn Motel. Assigned to Odawa Holding Corp for economic development.
- 5** **Mackinaw Casino, 13.25A (5)**
Odawa Casino in Mackinaw City. Gaming and Mukwa Bar and Grill.
- 6** **Wilderness Cabins, 1.36A**
LTBB owned cabins located in Wilderness State Park on Lake Michigan.
- 7** **St. James Bay Dock, 0.12A**
Lk. Michigan waterfront property that provides Tribal docking access to Beaver Island.
- 8** **Stone Circle, 79.86A (2)**
Newly acquired property with stones/rocks set by ancestors with constellation alignments.
- 9** **Wycamp Creek, 2.16A (2)**
Natural area located on Wycamp Creek.
- 10** **Cross Village, 8.31A**
Property located at the bottom of the bluff adjacent to boat launch in Cross Village.
- 11** **Ziibimijiwang, 311.74A (3)**
"Place of the flowing river"
LTBB farm and Tribal hunting area.
- 12** **Waawaashkesh, 76.84A**
Wild area for Tribal member hunting. For more information contact the LTBB NRD.
- 13** **Fish Hatchery/Aviary, 79.09A**
Location of LTBB fish hatchery & future aviary
- 14** **Osborne Road East, 38.15A**
Hunting available to Tribal citizens. For more information contact LTBB NRD.
- 14** **Osborne Road West, 38.27A**
LTBB Traditional Jingtamok-Ceremonial site. Closed to hunting.
- 15** **Lamkin Dr., 0.26A**
Small parcel purchased for cultural preservation.
- 16** **6108 Washington Pellston, 0.17A**
Tribal rental home
- 17** **6521 Mill, Pellston, 0.36A**
Tribal rental home
- 18** **WAH-WAHS-NOO DA KE, 80.92A**
Tribal housing community for citizens and their families. For more information contact the LTBB Housing Dept.
- 19** **Main Administration Campus, 96.68A**
Tribal Administration, Tribal Chairman and departmental programs offices. 7500 & 7845(NRD) Odawa Circle
- NW** **Native Way, Lease**
Tribal exercise facility available to Tribal citizens, employees, and their families.
- 20** **Biindigen Gas Station, 3.54A (2)**
Offers fuel, tobacco and convenience products to Tribal citizens and the community.
- 21** **Second Street Property, 2.09A (11)**
11 parcels in Harbor Spring's "Indian Town" used for Tribal housing.
- 22** **OEAH Parcel, 1345 US31, 1.13A**
Assigned to Odawa Holding Corp for economic development.
- 23** **Kishigo/Wall Parcel, 1.73A**
Parcel of land on M-119 adjacent to Indian Hills Gallery and bike path.
- 24** **Monroe St., 0.33A**
Future location of transitional housing.
- 25** **911 Spring Street, 0.96A**
LTBB offices of LTBB Tribal Court, Prosecutor, Police, Human Services

- 26** **910 Petoskey Street, 0.18A**
Tribal rental housing.
- 27** **915 Emmet Street, 0.17A**
Vacant building adjacent to Tom & Dick's Party Store.
- 28** **Odawa Hotel, 5.9A**
Owned and operated by LTBB. First class lodging, dining, and conference facilities to the Northern Michigan community and beyond.
- 28** **OEAH Parcel, Adj. to Hotel, 0.75A**
Assigned to Odawa Holding Corp for economic development.
- 29** **Bear River Health Park, 8.27A**
Home of all health, therapeutic, pharmacy services for the Tribal community.
- CM** **Commodities, Lease**
Food Distribution location. Back side of Fletches building. Call Human Services for more information, 231-242-1620.

- 29** **Victories Square, 30.03A (2)**
Area of new LTBB business development. Tenants include a hotel, restaurants, and retail. Property along Lears Road used for signage and winter snowmobile trail.
- 30** **Odawa Casino, 149.22A(3)**
Owned and operated by LTBB. Provides a wide variety of gaming, entertainment and dining options for Northern Michigan.
- 30** **Eppler Rd (Lollipop) Parcel, 14.59A**
Site for future development
- 31** **Lears1/Signage Parcel, 0.4A**
Parcel west of Anderson Road for signs.
- 32** **Cemetery Rd Parcel, 36.2A**
Site for future development
- 33** **Murray Road Property, 83.52A**
Energy efficient Tribal housing complex. Call the Housing Department for more information. Also the location of a traditional burial ground.

- 34** **Nine Mile Point Property, 1.42A**
Provides an access point to Little Traverse Bay and Lake Michigan for Tribal Citizens.
- 35** **Taimi Hoag Nature Preserve, 57.17A(3)**
3 parcels totaling 57 acres that encompass a nature preserve and nature trail that is adjacent to a Little Traverse Conservancy preserve. Open to Tribal hunting.
- 36** **St. Martin's Island Parcels, 51.47A (2)**
Land used for fishing safe harbor and Tribal research. Located approx 23 miles from SE of Escanaba in Lake Michigan. *Not displayed on this map.
- 37** **BayDeNoc Parcel, 20.5A**
Land used for fishing safe harbor and Tribal research. Located approx 3 miles south of US 2 near the town of Nahma on Big Bay De Noc. *Not displayed on this map.
- 38** **Pickerel Lake Parcels, 8.31A**
Land used economic development.
- 39** **Townline Rd, 37A**
Vacant wooded parcel of land.

- 40** **Cross Village 2, 0.39A**
Vacant parcel of land in Cross Village.
- 41** **Valley Road, 37.9A**
Vacant wooded parcel of land on Valley Rd.
- 42** **Devil's Elbow, 1A**
Vacant wooded parcel of land on M-119
- 43** **Wadsworth Parcels, 0.4A (2)**
Vacant parcels of land in Cross Village.
- 44** **East Gill Road Parcel, 58.6A**
Vacant swampland primarily used for treaty enhancement activities.
- 45** **220 W Van Road Parcel, 29A**
Vacant swampland primarily used for treaty enhancement activities.
- 46** **1393 N US 31 Parcel, 6.8A**
Vacant swampland primarily used for treaty enhancement activities.
- 47** **6201 Waterfront Dr. Parcel, 4.2A**
Homes near Lake Michigan in Cross Village used for economic development.
