Request for Funding from the Great Lakes Inter-Tribal Council, Inc., Great Lakes Inter-Tribal Epidemiology Center, Good Health and Wellness in Indian Country

- **WHEREAS** the Waganakising Odawak, known in English as Little Traverse Bay Bands of Odawa Indians is a nation of citizens with inherent sovereignty and right to self-governance;
- where the Little Traverse Bay Bands of Odawa Indians ("LTBB") is a federally recognized Indian Tribe under Public Law 103-324, and is a party to numerous Treaties with the United States the most recent of which being the Treaty of Washington of March 28, 1836 (7 Stat. 491) and the Treaty of Detroit of 1855 (11 Stat. 621);
- **WHEREAS** the Little Traverse Bay Bands of Odawa Indians Tribal Council is the elected Legislative body of the Tribe;
- **WHEREAS** commercial tobacco use continues to be a serious and growing problem for Native American communities throughout North America;
- **WHEREAS** diabetes is a recognized problem within the Little Traverse Bay Bands of Odawa Indians;
- **WHEREAS** promotion of physical activity to the Tribal community is a priority of the Little Traverse Bay Bands of Odawa Indians;
- **WHEREAS** the Great Lakes Inter-Tribal Epidemiology Center (GLITEC) has announced funds available to reduce deaths and disability from commercial tobacco use, diabetes, heart disease and stroke in American Indian/Alaska communities for a 60-month project period.

**THEREFORE, BE IT RESOLVED** that the Tribal Council of the Little Traverse Bay Bands of Odawa Indians authorizes and supports this grant application to the Great Lakes Inter-Tribal Epidemiology Center for a 60-month Good Health and Wellness in Indian Country project to reduce disparities in chronic disease and related risk factors to improve overall health outcomes.
