TRIBAL RESOLUTION# 102424- 03

**Supplemental Funding in the Amount of \$778,565.40 to come from Third Party
Revenue for FY 2024 Pharmacy Budget**

WHEREAS, the Waganakising Odawak Nation, known as the Little Traverse Bay Bands of Odawa Indians, and its citizens are vested with inherent sovereignty and right to self-governance; and

WHEREAS, the Little Traverse Bay Bands of Odawa Indians (LTBB) is a federally recognized Indian Tribe under Public Law 103-324, and is a party to numerous Treaties with the United States, the most recent of which is the Treaty of Washington of March 28, 1836 (7 Stat. 491) and the Treaty of Detroit of 1855 (11 Stat. 621); and

WHEREAS, the Little Traverse Bay Bands of Odawa Indians is governed by a Tribal Constitution adopted by the citizens of the Tribe on February 1, 2005; and

WHEREAS, in accordance with the WOS 2020-006, Tribal Government Budget Formulation and Modification Statute, Tribal Council authorizes and appropriates budgets through Tribal Resolutions; and

WHEREAS, the Health Department has an established Pharmacy serving tribal citizens;

THEREFORE, BE IT RESOLVED, The Tribal Council authorizes and approves Supplemental Funding in the amount of \$778,565.40 for FY 2024 to come from the Third Party Revenue for the Pharmacy Budget.

FINALLY, BE IT RESOLVED that in accordance with the Constitution, the Executive Branch shall administer such funds as appropriated by Tribal Council.

CERTIFICATION
